Subject: Saturation and AB109 Compliance Operation in the cities of Hemet, San Jacinto, and the unincorporated areas of Hemet

On September 1, 2016, a joint enforcement operation was conducted in the Hemet/San Jacinto Valley. The operation consisted of saturation patrol, attempt warrant services, and compliance checks on subjects on Post Release Community Supervision (PRCS), Mandatory Supervision, Parole, and Probation in the cities of Hemet, San Jacinto, and the unincorporated areas of Hemet.
